RE: Regular School Board Meeting, Monday, November 11, 2019.

The Tri-County School Board met for their Regular meeting on Monday, November 11, 2019. The following topics were covered:

1. Due to the weather, the Students of the Month and Showcases will be done at the December Board meeting.
2. Under Board Committee Reports, Mr. Pampel reported that there is a scheduled RWCDC meeting tomorrow evening, November 12, 2019.
3. Mr. Culp, updated the Board members on the construction project. Mr. Culp reported that over fall break, the tiles in the pool were cleaned. Gibraltar is checking into the tile company that put the tile in the pool, asking if it was cleaned properly before installing. The doors, cores and locks are installed and the grout in front of door #6 was only going to be covered and not new, so the job will be held until a correct way can be done.
4. Mr. Haskins reported to the Board that an eLearning Day was held on the same day as the Parent/Teacher Conference and 96.7% of the students signed in, so he was really pleased about this. Last week 125+ sophomores, juniors and seniors took the ASVAB test and they should have results next week. Last Saturday, the Middle School Robotics team had a competition at Klondike and Mr. Haskins feels like this has been a great learning experience and teamwork is used. Last Friday and Sunday was the fall play and he thanked Mr. Jeremy Sterk and Mrs. Christy Young for helping with the play and was so proud of all the students for doing such a great job. Mr. Haskins reported that the Veteran's Day Program was held at the high school today and he thanked Mr. Mick Benner, Government teacher, Mr. Jeremy Sterk and the band for providing the music, and Ms. Mollie Mosier and her culinary class for making the meal to serve the Veteran's that attended the program. All the students showed respect and were very well behaved. Midterm grades are out and once again Mr. Haskins, Mr. McCracken and the counselors are working with the students on probation because of grades and will be working with them to catch up. Mr. Haskins reported that the ISTEP Retakes will be on November 18-19. Both Basketball teams and Wrestling teams are well underway and there has been two weeks of Swim Club, which is co-ed and includes 6-12 grade students.
5. The Board approved the NEOLA policy changes as presented.
6. Mr. Pampel asked that the NARCAN discussion under New Business be tabled until the December meeting.
7. The Board approved a Resolution to allow the Treasurer to transfer funds from the Education Fund to the Operations Fund.
8. The Board approved the school corporation to transfer money from one major Budget classification to another in order to ensure that at the end of the year each fund has

a positive balance as required by the State Board of Accounts.

9. The Board approved the employment of Mr. Mike Harlow during the maternity leave of Mrs. Kailie Kaluf, beginning 2nd Semester.
10. The Board approved the appointment of Mrs. Pam Doughty to the Remington Carpenter Township Public Library for a second term.
11. The Board approved an Overnight and Out of State Field Trip Request from Mr. Travis Scherer and Ms. Haley Verhaeghe for the FFA National Soils Judging Contest in Oklahoma from May 4-8, 2020.
12. The Board approved the resignation of Mrs. Tammy Seward, effective November 22, 2019.
13. Mr. Culp reported that the Fall Play was very well done and Tri-County has many talented students. The School Resource Officer, Officer Andrew Lanoue has started and is very active in all 3 schools. Mr. Culp announced that the Veteran's Day Program was very impressive.
