The Tri-County School Board met for their Regular meeting on Monday, January 9, 2023. The following topics were covered:

- 1. Board Officers are as follows: Dr. Brandi Schermerhorn, School Board President, Mr. Bob Gerber, School Board Vice President and Mr. Jason Kilmer School Board Secretary.
- 2. The Board approved the reappointments of Tammy Seward as Treasurer and Mrs. Kristin Dreblow as Deputy/ Assistant Treasure with the amount of bond currently set at \$75,000.
- 3. The Board approved keeping Lewis-Kappes and Mrs. Monica Conrad as the Corporation attorney.
- 4. Students of the Month for Junior High are Adalynn Demerly and Jordy Martinez Morales. High School are Anthony Kendall (Social Studies), Ben Alberts (Fine Arts: Band), Nicole Walker (Math), Amalee Scheitlin (Language Arts), Elizar Aldez (Science), Grayson Schneider (CTE: Welding), Kevin Martinez (PE/Weights) and Jose Medina (English Language Learners).

- 7. Mr. Culp discussed renewing the Referendum and the timeline action steps required if the board approves, No action is required at this time.
- 8. There were no visitor comments.
- 9. Mrs. Shannon Kelly reported to the Board that she is preparing for the February ME count. She has started the project of creating the 2023-2024 Online Enrollment forms. She will be assisting Mr. LeBeau with the MWC Conference Wrestling meet this Saturday.
- 10. Mr. Culp reported that Chief Wirtz had not submitted anything at this time. Mr. Culp thanked Office Wirtz for all his time, effort and dedication to his position while at Tri-County. Officer Wirtz will be leaving due to accepting another position.
