- 1. Under Visitor comments, Mr. Brent Habegger from Baker Tilley reviewed the financial information regarding the decision to go with a 2-year or 3-year bond. No action was taken.
- 2. Mr. Culp reported to the Board, in the absence of Mrs. Shannon Kelly, that technology is busy uploading end of year state reports and preparing equipment for the 2021-2022 School Year.
- 3. Mr. Culp reported to the board that there are two pre-bid meetings coming up for the construction projects. The projects are TCP sidewalk, auditorium updates and air handling units.
